The ICMS community looks forward to being a part of your journey of growth, success and enlightenment.



Since leaving ICMS in 2017, Andrew has worked full time at ANZ, Sydney. He recognised the immense strategic value of the ANZ scholarship's internship component, which gave him the edge when seeking work post-graduation. It also gave him access to valuable banking experience, mentorship and network opportunities while still a student.

Q: Why did you apply for a scholarship from ICMS?

I applied for a scholarship from ICMS because of the range of scholarships offered and the reputation of the companies supporting them. The ANZ Bank scholarship appealed to me due to my interest in Corporate Finance post-graduation and the well regarded reputation of ANZ in domestic and international banking markets. I knew how competitive it was to gain an internship with any of the institutional banks and saw how valuable the scholarship opportunity was. Tuition support, as well as having the opportunity for a 13week paid internship at ANZ during my studies, certainly helped in starting off my career.

Q: What does your current role at ANZ entail?

I graduated from ICMS with a Bachelor of Business Management in 2017 prior to starting as a Graduate in ANZ's Institutional Bank. I have since been in a number of roles, including advising on Mergers and Acquisitions as well as advising on capital raisings. Most recently, I have been in a Leveraged and Acquisition Finance role providing debt financing to large corporates and private equity groups for the purposes of acquiring other businesses.

Q: How did you find the application process leading up to winning the scholarship?

I found the application process clear and easy to navigate.

The written component helped me explain what I was about and also why I was interested in applying for a scholarship in the first place. I also found the interviews were designed to discover your background and how well you were suited

Q: How do you think being an ICMS Scholarship award winner helped you in your career?

The ANZ Bank Scholarship has certainly helped in my career thus far. Through my internship, I was able to meet some great managers who helped me with advice and assisted me in the application process for the Graduate program after my study. I knew applying for the Graduate Program at ANZ would be competitive and my experience through the scholarship helped me in differentiating myself. The Erasmus+ Scholarship that allowed me to study abroad also gave my applications an element of international exposure which also helped.

Q: What are some of your highlights from your time at

The highlight of my time at ICMS would be the community at the college. The emphasis on academics was always balanced with a healthy focus on meeting people and social activities. I was fortunate enough to participate in a study abroad to Cologne, Germany, where I was able to meet friends from around the world who I am still in contact with and which also allowed for a lot of travel between classes. ICMS facilitated me being awarded the study abroad program through an Erasmus+ Scholarship from the European Union that provided financial support for travel and living expenses during my semester in Germany. This was not only a highlight of my studies, but was also a highlight from a personal perspective as well.

ICMS Professional Scholarship recipient and accounting student Keegan Du Preez is committed to balancing his entrepreneurial ambitions with his philanthropic goals.

In 2018, Keegan and his family moved to Australia from South Africa in search of new opportunities and an improved quality of life. First moving to Victoria, Keegan took full grasp of the opportunities presented to him. He became School Captain in the two short years he attended Australian school, and he started his own tutoring enterprise helping 30 students with their studies.

Keegan decided on an accounting specialisation, because "within every aspect of life whether that be professional or personal, you need an understanding of finance. With a finance degree, you can work in any department, especially with having a general business background."

When applying for a scholarship, Keegan impressed the Scholarships Interview Panel with his commitment to community and charity work. He runs a sub division of a charity in South Africa. The Matts Foundation supplies under-privileged children with food, water, shelter and clothing.

ICMS was Keegan's top choice when choosing where to study accounting, as he believes "ICMS is realistic. They understand the realistic expectations of various markets. It's not just textbook knowledge, especially compared to every other competitor." The industry placement component was also a big deciding factor when choosing a tertiary educational institution.


