The International College of Management (ICMS) has developed a scholarship program to reward the most promising scholars based on their effort, dedication, attitude and aptitude, demonstrated business acumen and motivation.

ICMS is offering a scholarship to a new domestic Postgraduate student who will be commencing their studies at ICMS in a 2-year Master program in May 2021.

The scholarship is awarded based on a three-component application process, which will result in the successful applicant being awarded a scholarship which offers a tuition waiver to the value of up to 6 subjects\* within one of the ICMS Master Degree programs commencing in May, 2021.

The ICMS Postgraduate Scholarship will be awarded based on the selection process implemented by the ICMS Scholarship board.

Value: Tuition Waiver up to Six (6) Subjects\*

Applications Due: by 5pm on Friday 23 April 2021, for domestic students commencing their Master degree in May 2021.

\* Equivalent to tuition fees for six (6) postgraduate subjects. Partial Scholarships may be awarded. Subject to approval by ICMS Management.

## Selection Process:

#### **Complete Application Form**

- Scholarship application form,
- ICMS Full Letter of Offer from ICMS Admissions,
- Academic proficiency,
- Essay,
- Photograph Headshot (School Photo is acceptable),

#### Finalists will be selected on the following three-step application process:

- 1. Academic requirements Due by 5pm on 23 April 2021
- 2. Innovation Essay submission Due by 5pm on 23 April 2021
- **3.** Interview: Finalists will be contacted by ICMS staff members to arrange an interview prior to commencing at ICMS. (Skype interviews may be necessary please advise your Skype details in section provided)

#### Step 1: Academic and English requirements

Applicants need to meet the ICMS entry requirements for Master Degree level study and have a GPA of 3.20 out of 5.0 from their previous undergraduate degree. Please refer to our College website for entry requirements www.icms.edu.au/courses



#### Step 2: Innovation Essay submission – Innovation (minimum 1000 words)

Applicants should address the following questions in the essay:

- The reasons for choosing ICMS, including the choice of program/specialisation
- What type of position do you see yourself in upon completion of your ICMS Master degree?
- Why do you think Innovation is so important in your working life? How can ICMS help you become more Innovative?
- Why are you the most appropriate student to be awarded this scholarship?

#### Step 3: Interview

- Students who are successful with their essay and ICMS entry requirements will progress to the interview stage.
- The student will be interviewed by members of the ICMS Scholarship Board and will be asked a broad range of questions relating to their knowledge of the College and course of their choice, their life and background in general.

#### Announcement

All applicants will be notified of the results by phone and email prior to trimester commencement.

A letter of acceptance will be issued outlining the details of enrolment at ICMS within two (2) working days.

#### Scholarship Acceptance

Upon notification of being awarded the ICMS Postgraduate Scholarship, the successful candidate is required to inform the College of acceptance or non-acceptance, in writing, within two (2) working days of receipt of notification.

NOTE: Scholarship submissions will not be returned. Unsuccessful applications are not retained and will be securely destroyed.



## **Terms & Conditions**

- 1. All applicants must be an Australian or New Zealand Citizen / permanent resident.
- The applicant is required to email their Scholarship Application to the below address by 5pm on Friday, 23 April, 2021 (Australian Eastern Standard Time).

- 3. Applications must include certified copies of:
  - Scholarship application form,
  - ICMS Full Letter of Offer from ICMS Admissions Office,
  - Academic proficiency,
  - Essay.
  - Photograph Head Shot (School photo is acceptable)
- 4. All final applicants will be contacted by ICMS within 5 working days after application closing date. Final applicants will be selected based on their essay and academic merit.
- 5. The scholarship offers a tuition waiver to the value of up to 6 subjects. Partial scholarships may be awarded.
- 6. ICMS Postgraduate Scholarships are not refundable and non-transferrable, meaning the scholarship cannot be converted to another program, education provider, or recipient nominated by the original recipient.
- 7. The deposit fee is to be paid as stipulated in the letter of offer, sent by ICMS.
- 8. An ICMS Postgraduate Scholarship may not be deferred. The scholarship must be redeemed by students commencing their studies in May 2021 Trimester only.
- 9. Any persons deemed to have misrepresented themselves in their application through fraudulent documents or identity in the interview will forfeit the scholarship and lose their deposit.
- 10. Once a student of ICMS, Scholarship recipients will be required to commit up to 10 contribution hours\* per week for the trimester the scholarship applies. Students will also provide the Marketing Department with a photo, profile and have a willingness to participate in future marketing.
- 11. Retakes or re-sits of a subject due to failing are to be paid for by the student and are not included in the Scholarship.
- 12. College fees and Awards are subject to change.
- 13. Scholarships are awarded for the May 2021 intake only in accordance with the enrolment procedure of the International College of Management, Sydney.
- 14. The College reserves the right to change or cancel all or part of the Scholarship program without notice.
- 15. Scholarship value is subject to change in line with program and fee changes.
- 16. Tuition fees are in Australian Dollars and are subject to change.
- 17. Applicants must have a full Letter of Offer in order to be eligible to apply for this Scholarship.
