The International College of Management (ICMS) has developed a scholarship program to reward the most promising scholars based on their effort, dedication, attitude and aptitude, demonstrated business acumen and motivation.

ICMS is offering a scholarship to new International Postgraduate students who will be commencing their full time or equivalent studies at ICMS in a 2-year Master program in February 2022.

The ICMS Postgraduate Innovation Scholarship will be awarded based on the selection process implemented by the ICMS Scholarship Board.

Value: Tuition Waiver **UP TO** the value of four (4) Postgraduate Subjects*
Applications Due: by 5pm on Friday 12 November 2021, for students commencing their Master degree in February 2022.

** PLEASE NOTE – Partial Scholarships are likely to be awarded when application numbers are high. All scholarships awarded are subject to approval by the ICMS Scholarship Board. Once the successful recipient has been notified of the scholarship value, that value is not negotiable and not changeable.*

Selection Process:

1. Complete Application Form

Email your submission to icmsscholarships@icms.edu.au (with “PG New International Student” in the email’s subject line) by 5pm Friday 12 November 2021 with the following required documents attached:

- Completed Scholarship Application Form,
- ICMS Full Letter of Offer from ICMS Admissions,
- English language proficiency (if applicable),
- Academic proficiency,
- Essay,
- Copy of Passport,
- Photograph – Head Shot (School photo is acceptable)

2. Finalists will be selected based on the following criteria:

a) Academic & English Requirement

Applicants need to meet the ICMS entry requirements in English language proficiency for Master Degree level study and have a GPA of 3.20 out of 5.0 from their previous undergraduate degree. Please refer to our College website for entry requirements www.icms.edu.au/courses.

b) Innovation Essay submission – Innovation (minimum 500 words and maximum 1000 words)

Applicants should address the following questions in the essay:

- The reasons for choosing ICMS, including the choice of program/specialisation.
- What type of position do you see yourself in upon completion of your ICMS Master degree?
- Why do you think Innovation is so important in your working life? How can ICMS help you become more Innovative?
- Why are you the most appropriate student to be awarded this scholarship?

c) Interview

- Students who are successful with their essay and ICMS entry requirements will progress to the interview stage. (Skype interviews may be necessary – please advise your Skype details in section provided)
- The student will be interviewed by members of the ICMS Scholarship Board and will be asked a broad range of questions relating to their knowledge of the College and course of their choice, their life and background in general.

Announcement

All applicants will be notified of the results by phone and email prior to study period commencement.

A letter of acceptance will be issued outlining the details of enrolment at ICMS within seven (7) working days.

Acceptance Procedure

Upon notification of being awarded the ICMS Postgraduate Scholarship, the successful candidate is required to inform the College of acceptance or non-acceptance, in writing, within two (2) working days of receipt of notification.

NOTE: *Scholarship submissions will **not be returned**. Unsuccessful applications are not retained and will be securely destroyed.*

Terms & Conditions (please read carefully before signing the declaration)

1. All applicants must provide certified copy of their passport.
2. The applicant is required to email their Scholarship Application to the below address by 5pm on Friday 12 November 2021 (Australian Eastern Standard Time).

3. Applicants must have a full time or equivalent study load to be eligible to apply.
4. Scholarship Applicants may only apply for one Scholarship per study period – Multiple scholarship applications will not be accepted.
5. Applications must include certified copies of:
 - Scholarship application form,
 - ICMS Full Letter of Offer,
 - Essay,
 - English language proficiency (if not from an English speaking country or ICMS asks for evidence of English)
 - Academic proficiency,
 - Passport,
 - Photograph – Head Shot (school photo is acceptable)
6. All final applicants will be contacted by ICMS within 5 working days after application closing date. Final applicants will be selected based on their essay and academic merit.
7. The ICMS Postgraduate Innovation Scholarship offers a tuition waiver **UP TO** the value of four (4) subjects. Partial scholarships are likely to be awarded when application numbers are high. Subject to approval by the ICMS Scholarship Board.

Accommodation/Living Costs Credit description:

Rooms are equipped with a desk, wardrobe, heating and wireless internet. All linen is provided and rooms are dusted and vacuumed once a week. Each floor is equipped with a kitchenette, common showers, toilets and ironing facilities. You will also receive residential support from the residential assistants. Your accommodation/Living Costs credit includes the following:

- Rent
 - 3 x Meals per day (Breakfast, Lunch and Dinner) – Monday to Friday
 - 2 x Meals per day (Brunch and Dinner) - Weekends
 - Electricity, Gas and Water
 - Onsite parking
 - Campus wide Wi-Fi
8. Once the successful recipient has been notified of the scholarship value, that value is not negotiable and not changeable.
 9. The Scholarship is not available to students using any other scholarship, bursary or discount at ICMS*.
 10. Previous scholarship recipients cannot have existing scholarship credit remaining as at the commencement of the study period they are applying for.
 11. ICMS Postgraduate Innovation Scholarships are not refundable and non-transferable, meaning the scholarship cannot be converted to another program, education provider, or recipient nominated by the original recipient.
 12. The deposit fee is to be paid as stipulated in the letter of offer, sent by ICMS.
 13. An ICMS Postgraduate Scholarship may not be deferred. The scholarship must be redeemed by students commencing their studies in February 2022 study period only.
 14. Any persons deemed to have misrepresented themselves in their application through fraudulent documents or identity in the interview will forfeit the scholarship and lose their deposit.
 15. Once a student of ICMS, Scholarship recipients are encouraged to commit up to 10 contribution hours** per week for the study period the scholarship applies. Students will also provide the Marketing Department with a photo, profile and have a willingness to participate in future marketing, blogging and College activities, and act as an ambassador for ICMS locally and if applicable in their home country.
 16. Retakes or re-sits of a subject due to failing are to be paid for by the student and are not included in the Scholarship.
