ICMS Allianz Care International Scholarship

The International College of Management (ICMS) has established a scholarship program to reward the most promising scholars based on their effort, dedication, attitude and aptitude, demonstrated business acumen and motivation.

The International College of Management, Sydney (ICMS) has partnered with ICMS Allianz Care International Scholarship to offer a scholarship to an international* postgraduate student who will be commencing their studies at ICMS in May 2026.

The scholarship is awarded based on a rigorous application process, which will result in the successful applicant being awarded a tuition waiver valued at up to AU\$15,000 to be applied to their course fees of one of the ICMS master's degree programs commencing in May 2026.

The ICMS Allianz Care International Scholarship will be awarded based on the selection process implemented by the ICMS Professional Scholarship board.

Value : **UP TO \$15,000 AUD tuition waiver**

Applications due: **5:00PM on Friday 3 April 2026**
For students commencing their degree in May 2026.

**Please note that New Zealand students are classed as Domestic and as such are not eligible to apply for this scholarship*

Study abroad note:

The ICMS Scholarships Program provides opportunities to students who are completing their bachelor's or master's degree with ICMS as their home institution.

As such, Study Abroad students are not eligible to apply.

Application Process

How to apply:

1. Ensure you meet the eligibility criteria listed below.
2. Gather and prepare the required documentation listed below.
3. Submit your application to icmsscholarships@icms.edu.au before the deadline – Subject line: ICMS Allianz Care International Scholarship

Please be advised that scholarship submissions will not be returned. Unsuccessful applications will not be retained and will be securely disposed of.

Eligibility criteria:

- Applicants must hold an active Allianz Care OSHC policy.
- Applicants must be a new international postgraduate student who will be starting full-time (or equivalent) studies in a master's program at ICMS in May 2026.
- Applicants must meet the ICMS English language proficiency requirements. (For detailed entry requirements, please visit our website at icms.edu.au/courses.)
- All required documentation, as listed below, must be submitted.

Required documentation:

- ✓ **ICMS Allianz Care International Scholarship Application Form:** A signed copy of the ICMS Allianz Care International Scholarship application form.
- ✓ **ICMS Letter of Offer:** Full signed Letter of Offer from the ICMS Admissions Office.
- ✓ **Essay Submission:** A 500-word minimum written essay detailing your background, experiences, and motivations (follow the Essay Submission Guide below).
- ✓ **Community, Leadership and Student Body Contributions:** Summary of your involvement in leadership roles, student councils, volunteering, and other community activities. You may include this either as a separate statement/document, in your application email, or within your essay submission.
- ✓ **Academic Records:** Official transcripts from any previous studies.
- ✓ **English Proficiency Documentation:** IELTS results documentation or equivalent (if applicable).
- ✓ **Allianz Global Assistance Overseas Student Health Cover (AGAOSHC) Policy:** All applicants are required to have an active AGAOSHC Policy.
- ✓ **Passport photocopy:** A valid copy of your passport.
- ✓ **Headshot photograph:** A recent photograph.

Essay Submission Guide

As part of your application for the ICMS Allianz Care International Scholarship Program, you are required to submit an original essay of at least 500 words. Your essay should thoughtfully address each of the following points:

1. **Why have you chosen ICMS?**

Explain your reasons for selecting ICMS, including your preferred program or specialisation.

2. **What unique qualities will you bring to ICMS?**

Describe the skills, experiences, and perspectives you will contribute to the ICMS community.

3. **Why are you the ideal candidate for this scholarship?**

Highlight what sets you apart and makes you most deserving of this opportunity.

4. **Where do you envision yourself in 10 years?**

Outline your long-term goals and how studying at ICMS will help you achieve them.

Tips for a Strong Submission:

- **Be specific:** Share examples of how your experiences have shaped your goals and vision for the future.
- **Be personal:** Let your passion for your field come through and show how it fuels your aspirations.
- **Be forward-thinking:** Focus on where you see yourself in five years and how ICMS will help you achieve that.

This is your moment to stand out and prove how your vision and ambition will guide you towards a successful and impactful future!

Selection Process

Interview stage

Following the assessment of the submitted documentation, a shortlist of finalists will be selected by the Scholarships Board for a panel interview, to be interviewed by members of the ICMS Scholarship Board and/or an Allianz Care representative.

During the interview, the student will be asked a broad range of questions relating to their knowledge of the College and course of their choice, as well as their life and background in general.

Final selection

The final scholarship recipients will be determined based on the assessment of both the submitted documentation and interview performance.

All applicants will be notified of the results by letter and/or email prior to study period commencement.

Accepting award

Upon notification of being awarded the ICMS Allianz Care International Scholarship, the successful candidate is required to inform the College of acceptance or non-acceptance, in writing, within two (2) working days of receipt of notification.

Enrolment fees must be paid upon acceptance of the students' Letter of Offer, and it is not refundable.

Terms and Conditions (please read carefully before signing the declaration):

1. All applicants must hold an international passport. This excludes dual citizens of Australia and elsewhere, permanent residents and temporary residents. New Zealand applicants are classified as domestic students and therefore are not eligible to apply.
2. All applicants are required to have an active Allianz Global Assistance Overseas Student Health Cover (AGAOSHC) Policy
3. ICMS Allianz Care International Scholarship are not refundable and non-transferable. The scholarship cannot be converted to another program, education provider, or recipient nominated by the original recipient.
4. The Scholarship Recipient agrees to abide by all admissions criteria and all requirements in the student handbook whilst enrolled. (<https://handbook.icms.edu.au/>)
5. The scholarship must be redeemed by students commencing their studies in May 2026 study period only.
6. If the Scholarship Recipient fails a subject, he/she is obliged to retake the subject at their cost at the full subject price.
7. The applicant is required to submit their Scholarship Application by 5:00PM Friday 3 April 2026 (Australian Eastern Standard Time).
8. Applications must include:

 - Community, Leadership and Student Body Contributions
 - Academic Records
 - English Proficiency Documentation
 - Allianz Global Assistance Overseas Student Health Cover (AGAOSHC) Policy
 - Passport photocopy
 - Headshot photograph
9. Applicants must have a full time or equivalent study load to be eligible to apply.
10. Scholarship Applicants may only apply for one Scholarship per study period – Multiple scholarship applications will not be accepted.
11. All final applicants will be contacted by ICMS within 5 working days after application closing date. Final applicants will be selected based on their essay.
12. The scholarship is a tuition (and/or accommodation) waiver that can only be used for the purpose of attending ICMS for the program as specified. The balance of remaining fees, including tuition, accommodation, uniforms, textbooks and any other program related costs for each enrolling study period must be paid in full prior to study period commencement.
13. The scholarship is to the total value of UP TO AU\$15,000. Partial scholarships are likely to be awarded when application numbers are high. Subject to approval by the ICMS Scholarship Board.
14. Accommodation/Living Costs Credit description:

Rooms are equipped with a desk, wardrobe, heating and wireless internet. All linen is provided, and rooms are dusted and vacuumed once a week. Each floor is equipped with a kitchenette, common showers, toilets and ironing facilities. You will also receive residential support from the residential assistants.

Your accommodation/Living Costs credit includes the following:

- Rent
 - 3 x Meals per day (Breakfast, Lunch and Dinner) – Monday to Friday
 - 2 x Meals per day (Brunch and Dinner) - Weekends
 - Electricity, Gas and Water
 - On-site parking
 - Campus-wide Wi-Fi
15. In certain cases, the scholarship amount awarded will be credited to tuition as a portion of the fees in each study period for the duration of the course of their study or until the scholarship credit is exhausted. In some cases, scholarship credit can and may be applied to a later study period than the commencement study period.
 16. In the case of the scholarship recipient discontinuing studies any and all remaining credit will be forfeited.
 17. The value of the scholarship and the timing of the credit apportionment are not negotiable and not changeable.
 18. Previous scholarship recipients cannot have existing scholarship credit remaining as at the commencement of the study period they are applying for*.
 19. If the recipient's scholarship involves a work placement and a tuition credit component, the tuition credit will apply to the next term of study.
 20. At no time will any scholarship credit apply to fees already paid.
 21. ICMS Allianz Care International Scholarship are not available to students using any other scholarship, bursary or discount at ICMS**.
 22. The deposit fee is to be paid as stipulated in the letter of offer, sent by ICMS.
 23. Any person deemed to have misrepresented themselves in their application through fraudulent documents or identity in the interview will forfeit the scholarship and lose their deposit.
 24. Where possible Scholarship recipients should consider doing some contribution hours*** each study period that the scholarship applies.
 25. Students will also provide the marketing department with a photo, profile and have a willingness to participate in future marketing, blogging and College activities and act as an ambassador for their country.
 26. Students will also provide the marketing department with a photo, profile and have a willingness to participate in future marketing, blogging and College activities and act as an ambassador for their country.
 27. ICMS scholarships may be discontinued by the College, dependent upon termly review of academic integrity, standing and student conduct.
 28. Retakes or re-sits of a subject or subjects due to failing the subject are to be paid for by the student and are not included in the Scholarship.
 29. Scholarships are awarded for the May 2026 intake only in accordance with the enrolment procedure of the International College of Management, Sydney.
 30. The College reserves the right to change or cancel all or part of the Scholarship program without notice. The Scholarship Board's decision is final and reserves the right to terminate the scholarship at any time for poor academic performance (see above), professional conduct, or inappropriate conduct (see ICMS Student Handbook)

31. Academic Integrity will be reviewed from time to time. Any academic misconduct can inhibit your scholarship. Academic misconduct registered as level 2 or 3 during the applicable scholarship, will result in immediate discontinuation of the scholarship.
32. Scholarship values are subject to change in line with program and fee changes.
33. Accommodation and tuition fees are in Australian Dollars and are subject to change.
34. Applicants must have a full letter of offer from ICMS Admissions to be eligible to apply for this Scholarship.
35. The ICMS Allianz Care International Scholarship may not be deferred.
36. College fees are subject to change.

*Exemptions may apply depending on the scholarship type.

**Excludes the ICMS Regional and Interstate Student Accommodation Bursary.

*** Contribution Hours can be discussed with the Scholarship Chairperson.
